- A) Mens: Keith McGruer

The League is in full operation, however there are lots of make-up matches going on. The standings are incomplete because a home team can only report scores when all three courts have been played. Most of the Maple Leaf teams have played, however the B5 team has only five players at the moment. The Captain is looking into getting a few subs from the 75+ team until a few more players can be recruited. I have emailed to the League Executive about a need to clarify rules for subbing **into** 75+ and subbing **out** of the 75+. Concerning the latter, current rules do not make allowance for players aging and becoming less mobile. A player might have come to 75+ from a B3 team four years ago, but is now not able to compete at that level.

Now that it is clearer as to which players are here or coming, we will likely be looking at some player shifts in the near future.

B) Ladies: Kate Lilley

All 6 of our ladies teams are back playing League in some type of form. Three of our teams are back playing league inside and outside of our park. One team only has 2 players until December and have starting playing one court. The two remaining teams are playing league games in our park but only have a few that will play out if the park at this time.

Each team is handling their own Covid protocols to their own team's comfort levels. We have 5 lessons with Tony on Mondays and will be adding a sixth in January. We have lost a few lady team members and have some on medical. We will be reevaluating the number of teams for next season in January. Numbers are down and we are hoping on recruiting new members after Christmas and will reevaluate team placements for next year. Some teams are missing members. Some teams only have 7 members.

A committee will be formed a subcommittee to discuss lesson taking by teams. Jack will form it.

As to court equipment, a number of replacements were in order as in past years, like sun protecting umbrellas that were torn by Mother Nature, a large windscreen, the large clock over the bulletin board at Charlotte and other such things. Using a suggestion made to me by Murray, I also made sure we have some items backed up should they fail, like one of the reel assemblies that hold up our nets. In a previous report, a late spring Improvement Committee agreed that when courts are wet on various event days and needed in a hurry, the best method to allow the sun and wind to do their magic is to spread the water out with the available carpets and brooms. New brooms will soon be installed at all the courts. However, on one recent occasion, maintenance showed up with blowers and rescued us, but may not always be available.

Once again, I want to recognize Tim Llewellen who has now taken on the task of windscreens ups and downs, nets ups and downs, and other court issues like replacing umbrellas. We worked together with a good group of volunteers and he did a great job leading these tasks. Sherm Stubbert, who more or less retired from these responsibilities can't help himself and continues to jump in and help.

We do need to discuss our continued support for Tony as our designated Professional for team lessons at today's meeting.
